APPLICATION FEE

A non-refundable application fee of S\$2,500.00 must accompany all applications. In the event the application fee is not paid, the application will be rejected. The application fee may be paid online. Any online payments will incur a 3.5% administrative fee. Students who leave CIS and wish to return at any point in the future must submit a new application. LATE PAYMENTS

CIS will impose a late payment fee of 1% per month on any fee payments that are not received by the due date that is indicated on the invoice. CIS considers payment made 1 day after the invoice due date(s) as late.

PRO-RATING OF FEES

Students commencing classes midway through a semester may have their tuition fees and support programme fees (if applicable) prorated by month. This means that students commencing classes mid-month are required to pay tuition fees and support programme fees (if applicable) for the entire month. The pro-rated tuition fees and support programme fees payable for each month of the school year vary from month to month based on the fees to be consumed. The fees payable for midway entry can be requested from CIS.

MISCELLANEOUS FEES

FEE PROTECTION SCHEME (FPS INSURANCE)
